Sealed quotations are invited from authorised persons/firms for the providing Floodlight for Elevens Football Tournaments (For three days) in the the football pitch in connection with the conduct of All India Inter University Football (M) 2017-18 Tournaments. The necessary superscription, due date for the receipt of quotations, the date up to which the rates will have to remain firm for acceptance and the name and address of officer to whom the quotation is to be sent are noted above.

Any quotation received after the time fixed on the due date is liable to be rejected. The maximum period required for making the facilities will be on 30.12.2017 at 10 AM. Quotations not stipulating period of firmness an Sealed quotations are invited for the providing Floodlight for Elevens Football Tournaments in the the football pitch in connection with the conduct of South Zone Inter University Football (M) 2017-18 Tournaments. The necessary superscription, due date for the receipt of quotations, the date up to which the rates will have to remain firm for acceptance and the name and address of officer to whom the quotation is to be sent are noted above.

The acceptance of the quotations will be subject to the following conditions:

1. Acceptance of the quotation constitutes a concluded contract. Bidder has to take a DD for Rs.450/- in favour of the Finance Officer as EMD for participating in the Quotation.
2. Withdrawal from the quotation after it is accepted or failure to provide service within a specified time or according to specifications will entail cancellation of the order and the avail of any other services being made at the offerers expenses from elsewhere, any loss incurred thereby being payable by the defaulting party. In such an event the University reserves the right to remove the defaulter's name from the list of University service providers permanently or for a specified number of years.
3. The quotation will be opened only on the specified date.

4. No representation for enhancement of price once accepted will be considered during the currency of the contract.
5. Any attempt on the part of tenderer or their agents to influence the Officers concerned , by personal canvassing will disqualify the tenderers.
6. If any license or permit is required, tenderers must specify in their quotation and also state the Page 1 of 2 authority to whom application is to be made.
7. The quotation may be for the entire or part service. But the tenderers should be prepared to carry out such portion of the services included in their quotation as may be allotted to them.
8. In cases where a successful tenderer, after having made partial fulfillment of the work and fails to fulfill the contracts in full, all or any of the service as required not provided may, at the discretion of the Purchasing Officer be availed service by means of another tender/quotation or by negotiation or from the next higher tenderer who had offered to supply already and the loss if any, caused to the University shall thereby together with such sums as may be fixed by the University towards damages ,be recovered from the defaulting tenderer.
9. The prices quoted should be inclusive of all taxes (Including GST), duties, cesses, etc., which are or may become payable by the contractor under existing or future laws or rules of the country of origin/supply or service or delivery during the course of execution of the contract.
10. (a) Ordinarily payments will be made only after the completion of the function payments against satisfactory completion of the work / Service will be made after completion of the championship.
(b) The tenderers shall quote also the percentage of rebate (discount) offered by them in case the payment is made promptly within fifteen days of the conduct of the function.
11. Any sum of money due and payable to the successful tenderer or contractor from University shall be adjusted against any sum of money due to University from him under any other contracts.
12. Special conditions, if any, printed on the quotation sheets of the tenderer or attached with the quotation will not be applicable to the contract unless they are expressly accepted in writing by the purchaser.
13. The firms have registered under goods and service tax only entertain to involve in the quotation and they will be able to submit all the bills as per the new GST norms.
14. The firm with a valid license from the authority concerned only need to involve in the quotation. It is the duty of the bidder to ensure the safety and other precautions regarding installing of the Floodlight.
