ORDER

As per U.O read as (1) above, the revised Regulation, Scheme and Syllabus of MBA programme (CUCSS) under School of Distance Education was implemented with effect from 2013-14 admission.

As per reference cited as (2) above, School of Distance Education informed that the Admission supervisory Committee (ASC) issued direction that an entrance examination, viz, All Kerala MBA Entrance test, in the name and style of "KMAT" be conducted from 2015 academic year onwards for admission to MBA in all organisations/institutions/Universities conducting MBA entrance test by themselves and all other tests by others will be disallowed and the admission of any candidate for MBA course other than from the list of CAT,MAT,CMAT and KMAT will be rejected by ASC.

As per item No.5 of the paper read as (4) above, the Board of Studies in Management (PG) discussed the matter and resolved to approve CAT/CMAT/KMAT as the only eligible admission test for MBA (SDE) admission from 2016-2017 admission onwards

As per paper read as (5) above, the Faculty of Commerce and Management studies in its meeting held on 30.11.2016 resolved to approve the Minutes of the meeting of the Board of Studies in Management (PG) read as (4) above.

The meeting of the Academic council held on 13.12.2016, approved vide paper read as (6) above, the minutes of the meeting of the Faculty of Commerce and Management Studies read as (5) above and the Minutes of various Board of studies coming under the Faculty.

Sanction is accorded by the Vice Chancellor to implement the Items in the minutes of Academic council vide paper read(7) above.

Sanction is accorded to issued the following order:

- 1.CAT/CMAT/KMAT will be the only eligible admission test for MBA (SDE) admission from 2016-17 admission onwards.
- 2.Clause 3.0 Admission proceedure, of the regulation of MBA programme under Distance Education under CUCSS mode, implemented vide U.O read as (1) above, stands modified to this extent.
