- iv) Matriculation Fee : ₹100/- (for those who are enrolling in Calicut University for the 1st time.)
- v) Re-matriculation Fee : ₹150/- (for those who have migrated from Calicut University to other Universities)

- vi) Recognition Fee : ₹100/- (for those who have qualified from Boards/Universities of other states)
- vii) Postage charges : ₹50/- (for those who are not availing the facility of spot admission)
- viii) Spot admission fee : ₹50/- (for those who are availing the spot admission facility)

1st year tuition fee also to be remitted at the time of application and IInd year tuition fee is to be remitted after the completion of 1st year examinations/before the commencement of IInd year. SC/ST/OEC students are eligible for concession from payment of tuition fees, only if they are not employed in Govt./Quasi Govt./Public Sector services. They should apply for fee concession with relevant documents in the prescribed application (available in the SDE website) at the time of admission. *No fee concession for OBC students. Blind candidates are also eligible for fee concession on production of Medical Certificate.*

IV. Mode of remittance of Fees

All the fees should be remitted online only through the Instant Web Payment utility available in the University Website(www.universityofcalicut.info).

V. Mode of application.

Application is to be submitted online using the online registration facility provided in the university website. The printout of the application along with the required documents should be submitted to the School of Distance Education either directly or by post.
