**NOTIFICATION FOR PRIVATE REGISTRATION TO BA MULTIMEDIA PROGRAMME  
FOR THE ACADEMIC YEAR 2017-2018.**

Applications are invited for Private Registration to the BA Multimedia programme for the academic year 2017-2018.

**I. Eligibility for Admission.**

Candidates who have passed the Higher Secondary Examination, Kerala or equivalent examination with not less than 45% marks in aggregate shall be eligible for admission to BA Multimedia programme. Relaxation of 5% marks will be allowed to candidates belonging to Socially and Educationally Backward communities as referred to Government of Kerala. SC/ST candidates need have only a pass in their qualifying examination.

Candidates who have passed the Higher Secondary Examination of Tamil Nadu(Private Study) shall not be admitted to the BA Multimedia programme (U.O.No.GA I/A1/5062/2002 dated 07/07/2005)

**II. Duration of the Programme.**

The programme shall be of six semesters spread across 3 years.

**III. Schedule of Application.**

**IV. Details of fee to be remitted at the time of registration.**

i. Private Registration Fee	: ₹14,000/-
ii. Matriculation Fee	: ₹100/- (For those who are enrolling in University of Calicut for the 1 <sup>st</sup> time)
iii. Re-matriculation Fee	: ₹150/- (For those who have migrated from the University of Calicut to other Universities)
iv. Recognition Fee	: ₹100/- (for those who have qualified from Boards/Universities of other states)
v. Postage Charges	: ₹50/-

**V. Documents to be attached along with the application.**

1. Original chalan receipt for the required fee.
2. Original Transfer Certificate (T.C)
3. Original and copies of qualifying certificates and marklists.
4. Self attested copy of SSLC or equivalent for proof of age and date of birth.
5. Those who are eligible for mark relaxation on the basis of caste should submit original community certificate.

6. Those who have completed Plus Two through National Institute of Open Schooling(NIOS) should submit an Equivalency Certificate issued from the University of Calicut.
7. A self addressed envelope (without stamp) of size 30cm x 25cm.
