Applications are invited for admission to the 12 Post Graduate Programmes under the School of Distance Education, University of Calicut for the academic year 2019-20.

**II. Details of Fees to be remitted at the time of admission.**

- i) Admission Fee : ₹500/-
- ii) Tuition Fee for One Year
  - a) MA ( Arabic, Malayalam, History) : ₹2760/-
  - b) MA (English, Economics, Hindi, Philosophy, Political Science, Sanskrit, Sociology, ) : ₹2205/-
  - c) M.Com : ₹2760/-
  - d) MSc Mathematics : ₹2205/-
- iii) Matriculation Fee : ₹115/- (for those who are enrolling in Calicut University for the I<sup>st</sup> time)
- iv) Re-matriculation Fee : ₹170/- (for those who have migrated from Calicut University to other Universities)
- v) Recognition Fee : ₹115/- (for those who have qualified from Boards/Universities of other states)
- vii) Postal charges / Spot admission fee : ₹60/-

Candidates have to remit their I<sup>st</sup> year tuition fee also the time of registration. II<sup>nd</sup> year tuition fee is to be remitted after the completion of I<sup>st</sup> year examinations/before the commencement of II<sup>nd</sup> year. SC/ST/OEC students are eligible for concession from payment of tuition fees, only if they are not employed in Govt/Quasi Govt./Public Sector services. They should apply for fee concession with relevant documents in the prescribed

application( available in the SDE website) at the time of admission.No fee concession for OBC students. Visually Challenged candidates are also eligible for fee concession on production of Medical Certificate.

All the fee should be remitted online only through the Instant Web Payment System available in the University website ([www.universityofcalicut.info](http://www.universityofcalicut.info)).

### **IV. Mode of application.**

Application is to be submitted online using the online registration facility provided in the website of the School of Distance Education ([www.sdeuoc.ac.in](http://www.sdeuoc.ac.in)). The printout of application along with the required documents should be submitted to the School of Distance Education either directly or by post. **Candidates are directed to read the Prospectus before submitting the online application.**
