ORDER

The Meeting of the Board of Studies in Law (UG) held on 27 th of August 2019 considered the matter of giving an opportunity for improvement of internal marks for students of Under Graduate Programmes in Law in the University. The Board noticed the fact that in other Universities in the state and outside the state, opportunity is not totally denied for improvement of internal marks and in deserving cases , subject to conditions, students are allowed to improve their internal marks by re-doing the same .The Board therefore resolved vide paper read (1) above to allow ONE chance per subject/paper for improving internal assessment marks for students of Under Graduate Programmes in Law of the University subject to the guidelines as decided.

The Minutes of the meeting of the Board of Studies in Law (UG) held on 27.08.2019 was approved by the Faculty of Law vide paper read as (2) . The Academic Council in its meeting held on 05.10.2019, vide paper read as (3), approved the minutes of the meeting of the Board of Studies in Law (UG) and the minutes of the meeting of the Faculty of Law read as (1) and (2) respectively with a modification to the guidelines for Improvement of Internal Assessment marks of LLB (3 Year) Unitary Degree and BBA.LLB (Honours) Programmes by adding the clause that internal re-do for all papers/subjects should be done at a stretch. Sanction has been accorded by the Vice Chancellor to implement the decision of the Academic Council in this regard.

The students of Under Graduate Programmes in Law of the University are therefore allowed ONE chance per subject/paper (excluding clinical/practical papers) for improving internal assessment marks subject to the following guidelines as decided by the Academic Council.

(1) Re-doing of internals for improvement of marks shall be permitted only after completion of the course. During the course period, no re-doing of internals shall be allowed in any subject in the curriculum.

(2) The following categories of students shall not be eligible for improvement of internal assessment marks obtained in a subject/paper:

a. Students who have successfully completed the course.

b. Students who have secured 50 percent or more marks for internal assessment in the subject/ paper concerned.

c. Students who have passed the subject/paper concerned.

(3) An application for improvement of internal assessment marks obtained in a subject/paper by re-doing the same shall be made within one year from the date of written examination in the last subject in the final semester of the course concerned conducted by the University. Provided that this condition may be waived once, after notification of these guidelines, for students in whose case the one-year period has already elapsed.

(4) The eligibility for improvement of internal marks shall generally be limited to one paper for every semester. Provided that, if any student has not availed the benefit of improving the internal marks in a paper in any semester, the eligibility for the same may be carried forward to any paper in any other semester, subject to a maximum of ten papers in total.

(5) Only one chance shall be allowed for re-doing internals for improvement of internal marks for a student in a particular subject/paper. If the candidate is eligible for re-doing internals for more than one paper/ subject and if he desires to do so, a single application should be made for the purpose for all the papers.

(6) Each student who fulfills the above conditions and intends to re-do the internals should make an application to the University and remit the prescribed fee per paper, as fixed by the University. The fee at the prescribed rate for all the papers/ subjects for which the candidate desires to re-do internals shall be paid at a single instance.

(7) On verification of the eligibility of the student for re-doing internals, the University may issue an order to the department/college/ institution concerned for the purpose.

(8) The Head of the department/college/institution, on receipt of the University Order, shall make arrangements for re-doing the internals subject to the condition that the teacher who valued the original internal assessment shall not be entrusted with the re-evaluation of the internals.

(9) The student shall re-do the required components of internal assessment as instructed by the teacher concerned in accordance with Regulations applicable to the candidate concerned. The component of marks for attendance, if any, shall be the marks obtained by the candidate while she attended the semester on a regular basis.

(10) A maximum of 90 working days may be given for completing the internal assessment process by the teacher concerned.

(11) The revised marks shall be forwarded from the department/college/Institution to the University within 100 working days from receipt of the University order.

(12) Improved internal marks is to be given in the session in which candidate has scored the highest external mark in the subject. (The candidate should submit copy of the mark list along with the application for internal marks improvement).

(13) Month and year of passing of the subject as a result of the internal improvement shall be considered as the month and year of passing the subject and reflected in the mark sheet accordingly

(14) Internal re-do for all papers/subjects should be done at a stretch.

Orders are issued accordingly.
