ORDER

As per the paper read as (1) above, the Principals of Naipunnya Institute of Management and Information Technology, Koratty, Thrissur and Yuvakshetra Institute of Management Studies, Ezhakkad, Palakkad were informed of the orders of the Vice-Chancellor regarding conducting a separate examination for the V Semester (CUCBCSS - UG) Open Course Regular / Supplementary / Improvement November /2019 for those colleges whose students had gone for an Industrial training, by levying the cost for this examination.

As per the paper read as (2) above, the Principal,Naipunnya Institute of Management and Information Technology, Koratty, Thrissur requested to reconsider the decision to penalise the colleges.

The entire matter was placed before the Standing Committee on Examinations held on 11/02/2020 and SC on Examinations, as per paper read as 3rd above, vide item No. 13/5 considered the matter of recovering the cost of conducting the re-examinations for the open course of Fifth Semester CUCBCSS - UG from the colleges offering B.Sc Hotel Management and Culinary Arts and B,Sc Hotel Management and Catering Science course for not conducting the examination on the scheduled date and resolved to recover the cost as follows:

1. BSH/C5D02: Rs. 2000/- from each college (8x2000=Rs. 16000/-)

2. BSH/C5D01: Rs. 1500/- from each college (5x1500=Rs. 7500/-)

Accordingly the following colleges are directed to pay the fine amount detailed below to the Calicut University Fund and to produce the chalan urgently for conducting the special examination for V Semester (CUCBCSS - UG) Open Course Regular / Supplementary / Improvement November /2019.
