<u>ORDER</u>

As per U.O read 1 above, the Additional and Chief Examiners will be eliqible for one day duty leave for every additional 50 numbers of answer scripts valued/revalued by them over and above the mandatory minimum as part of duty of teachers drawing UGC scale of pay .The teachers attending the CV Camps from self financing colleges are not eliqible for this duty leave. Majority of the teachers attending CV Camps are from self financing colleges and they have expressed their unwillingness to participate in the CV Camps commenced on 23/07/19.

Considering the exigency and to ensure the participation of faculty from self-financing colleges in the CMV Camp commenced on 23.07.2019, the Vice-Chancellor has accorded sanction to issue a modified U.O.No.728/2019/PB dtd 22/7/19 for extending the benefits of remuneration package implemented vide U.O.No.583/2018/PB dated 08.10.2018 to the teachers from self-financing colleges also, subject to ratification by the Syndicate.

The matter is placed before the Syndicate for ratification of the action taken by the Vice-Chancellor in having accorded sanction for extending the benefits of remuneration package implemented vide U.O.read 1 above, to the teachers from self-financing colleges also.

As per extract of the minutes read 3rd above, the meeting of the Syndicate held on 05/11/19 Item No.2019.1035 (Confirmed vide item No.2019.1170 on 3/12/19) considered the matter and ratified the action taken by the Vice-Chancellor in having accorded sanction for extending the benefits of the remuneration package implimented vide U.O.No.583/2018/PB dated 08/10/18 to the teachers from the self financing colleges also.

Considering the matter in detail, sanction has been accorded by the Vice-Chancellor on 23/02/2020 for implementing the decision of the Syndicate vide Item No.2019.1170.

Therefore, the order cited first above, is made absolute.
