Vide paper read as (2) above, the Chairman, Board of Studies in English UG informed that the members and the Chairperson of the Board of Studies examined the application of the candidate and syllabus of regular BA Triple main programme (English Literature, Communication and Journalism) of MG University, Kottayam and found that BA Triple main (English Literature, Communication and Journalism) of MG University has more than 50% of the core courses offered under the BA English Language and Literature programme of the University of Calicut and also more than 50 % of the total credits offered under the programme. In the light of these findings as well as in tune with the procedure for granting equivalency to Triple main programmes approved by the Academic Council, the Board of Studies in English (UG) recommended to grant equivalency to the regular BA Triple main programme (English Literature, Communication and Journalism) of MG University, Kottayam as per the requirement and request of Ms. Mrithula Varghese.
