**ORDER**

As per read as (1) above, the Vice Chancellor, Kerala Agricultural University submitted a proposal to grant equivalency to Five year Integrated Climate Change Adaptation Programme of Kerala Agricultural University.

Vide paper read as (2) above, the Chairman Board of Studies in Geology pointed out that, since the University of Calicut did not offer an Integrated course related to Earth Science, the request of equalization could not be considered. It was also remarked that BSc-MSc Five year Integrated Climate Change Adaptation Programme offered by Kerala Agricultural University could not be considered as equivalent to BSc.Geology and /or MSc.Applied Geology of the University of Calicut.

Vide paper read as (3) above, the meeting of Board of Studies in Geography resolved that MSc.Geography of the University of Calicut was not a corresponding programme to BSc-MSc Five year Integrated Climate change Adaptation Programme offered by Kerala Agricultural University. Since the total content of the syllabus of the programme was much less than the syllabus of MSc.Geography of the University of Calicut, the Board recommended not to grant equivalency to BSc-MSc Five year Integrated Climate Change Adaptation Programme offered by Kerala Agricultural University with MSc Geography of the University of Calicut.

Vide paper read as (4) above, the LXXIX meeting of Academic Council approved the above resolution of Board of Studies as approved by the Faculty of Science held on 05.12.2018.

Vide paper read as (5) above, the Board of Studies in Environmental Science and Water Management observed that BSc-MSc Five year Integrated Climate Change Adaptation Programme offered by Kerala Agricultural University could not be equated with M.Sc Environmental Sciences of the University of Calicut, since the said integrated programme dealt with subjects in Mathematical, Physical and Biological Sciences, focussing on Climatology. However, the Board recommended to consider BSc-

MSc Five year Integrated (10 semester) Climate Change Adaptation Programme offered by Kerala Agricultural University as one among the basic qualifications needed for getting admission to Ph.D in Environmental Sciences of the University of Calicut.

Vide paper read as (6) above, the meeting of Faculty of Science approved the recommendation of the Board of Studies in Environmental Science and Water Management to consider BSc-MSc Five year Integrated (10 semester) Climate Change Adaptation Programme offered by Kerala Agricultural University as one among the basic qualifications needed for getting admission to Ph.D in Environmental Sciences of the University of Calicut.

Vide paper read as (7) above, the LXXX meeting of Academic Council approved the recommendation of the Board of Studies in Environmental Science and Water management as approved by the Faculty of Science.

Sanction has been accorded by the Vice Chancellor to implement the resolution of Academic Council accepting BSc-MSc Five year Integrated (10 semester) Climate Change Adaptation programme offered by Kerala Agricultural University as one among the basic qualifications needed for getting admission to Ph.D in Environmental Sciences of the University of Calicut.
