ORDER

As per paper read as 1st above, the EAC Section, Finance Branch informed that the rate of remuneration for the valuation of Certificate & Diploma course in Russian has not been fixed so far and hence, the bills regarding theory and practical examinations are kept pending. Accordingly, being the Chairman, Board of Examiners, the HoD, Department of Russian and Comparative Literature was requested to forward a proposal for the same.

The HoD forwarded a proposal as per paper read as 2nd and the Standing Committee of the Syndicate on Examinations vide paper read as 3rd above, considered the proposal and resolved to place it before the Syndicate with recommendation.

The Syndicate, as per paper read as 4th above, approved the proposal. But, the Syndicate held on the same day (06/05/2017) enhanced the rate of remuneration for the valuation of answer scripts of UG & PG Courses and the Chairman's fee in respect of CV Camps, leading to an anomaly in implementing the Syndicate resolution on fixing the rate for the Certificate & Diploma courses in Russian.

Hence, the Hon'ble Vice-Chancellor accorded sanction to place the matter again before the Syndicate for reconsideration and the Syndicate held on 20/06/2017, as per paper read as 5^{th} above, vide item No. 2017.670^* resolved to revise the remuneration for the Certificate & Diploma courses in Russian as in the revised remuneration rates for UG, PG courses and Chairman's fee.

Sanction has been accorded by the Hon'ble Vice-Chancellor to implement the decision of the Syndicate to revise the remuneration for the Certificate & Diploma Courses in Russian as in the revised remuneartion rates for UG, PG Courses and Chairman's fee. The Syndicate decision is, therefore, implemented.
