**ORDER**

As per paper read as 1<sup>st</sup> above, the Syndicate at its meeting held on 20/06/2017, arising out of discussion, vide item No. 2017.745\*, resolved to grant compensatory allowance of ₹400/- (Rupees Four Hundred only) to teachers engaged on examination duty within a distance of 8 k.m w.e.f 17/05/2017. A clarification was sought on the resolution since it was not specified whether this allowance is for a day or for the examinaion / camp as a whole, and also on the term 'examination duty'.

Accordingly, as per paper read as 2<sup>nd</sup> above, the Syndicate held on 12/07/2017 vide Item No. 2017.751 emended the decision of the Syndicate held on 20/06/2017 vide Item No. 2017.745\* as "Arising out of discussion, it was resolved to grant compensatory allowance of ₹400/- per day to teachers attending C V Camps for vauation within a distance of 8 km w.e.f 17/05/2017.

Sanction has been accorded by the Hon'ble Vice-Chancellor to implement the decision of the Syndicate. Therefore, the resolution of the Syndicate to grant compensatory allowance of Rs.400/- per day to teachers attending CV camp for valuation within a distance of 8 km w.e.f. 17.05.2017, is implemented.

The University Order read as 3<sup>rd</sup> above, therefore, stands cancelled.
