## ORDER

As per paper read as 1<sup>st</sup> above, the mandatory number of answer scripts to be evaluated by the teachers drawing UGC scale of pay as part of duty (free of remuneration) was fixed. As per paper read as 2<sup>n d</sup> above, the number of papers to be evaluated by a teacher per semester, mandatorily, without remuneration, for the Arts / Humanities and Science Courses was also fixed.

Since the mandatory number of scripts to be evaluated for Professional course was not mentioned in the UO's read 1 & 2 above, the question of fixing of mandatory number of answer scripts to be evaluated without remuneration by teachers drawing UGC Scale of pay in respect of Professional courses was placed before the Syndicate for consideration. As per paper read as 3<sup>rd</sup> above, the Syndicate held on 20/06/2017 considered the matter, vide item No. 2017.610\*, and deferred for detailed study by the Standing Committee on Examinations.

The Standing Committee of the Syndicate on Examinations as per paper read as 4<sup>th</sup> above, constituted a Committee for a detailed study of the matter. The Committee met on 03/08/2017, and as per paper read as 5<sup>th</sup> above, recommended the following:

1. As per U.O. No. 231/2017/PB datd 29/03/2017, the mandatory number of answer scripts to be evaluated by the teachers drawing UGC Scale of Pay as part of duty without remuneration has been fixed. The Committee recommended that the valuation of answer scripts is part of duty of teachers. It is obligatory that every teacher should evaluate the answer scripts alloted to him/her by the University, of which the mandatory minimum number of answer scripts shall be evaluated without remuneration, as part of their duty. If a teacher abstains from evaluation duty, it will be considered a punishable offence and will

be liable for the financial losses occurred to the University.

2. The mandatory number of answer scripts to be evaluated without remuneration by the teachers drawing UGC Scale of pay per semester for the Professional courses are detailed below:

\* B.Ed, B.P.Ed, L.L.B, B.M.M.C, B.Tech - 30

\* (a) B.Arch, BFA, BTTM - 20

(b) BTHM - 25

\* B.Lisc - 10

\* MCA, M.P.Ed - 15

\* M.Ed, MCJ, M.Lisc, L.L.M, M.Tech - 10

\* MBA - Since there are no Govt. / Aided Batches and no teachers drawing UGC Sclae of pay, mandatory minimum number of answer scripts to be evaluated is not applicable.

\* B.P.Ed (4 year course) - In the yearwise pattern, 50 per year.

As per paper read as 6<sup>th</sup> above, the Standing Committee of the Syndicate on Examinations considered the recommendations of the Committee, and resolved to place the same before the Syndicate with recommendations.

The Syndicate, vide paper read as 7<sup>th</sup> above, considered the same and resolved to approve the sub committee report.

Sanction has been accorded by the Hon'ble Vice-Chancellor to implement the decision of the Syndicate.

The Syndicate resolution is, therefore, implemented.
