ORDER

As per paper 1 read above, the Government, as part of its initiative to raise non-tax revenue, enhanced the fees /charges levied by all Govt. Departments and Public Sector/Grant-in-aid institutions for various services offered to the public by 5% w.e.f 1. 4. 2018 and directed the heads of such Departments/Public Sector/Grant-in-aid institutions to issue necessary orders with details of revised rates and report to the Finance department.

As per paper 2nd read above, the Vice Chancellor, in consonance with the resolution of the Syndicate, accorded sanction to implement the aforesaid GO in the University w.e.f 1.4.2018 and directed all Branch Officers, Heads of Teaching Departments and Heads of University Centres to issue orders enhancing the fees/charges levied by the respective departments for the services offered by them by 5% w.e.f 01.04.2018.

The fees/charges levied for all services offered by the College Development Council are therefore enhanced by 5% w.e.f 01/04/2018. The detailed list of the existing and the revised rates is annexed.
