**ORDER**

The Chairman, B.Voc MLT course, requested to fix the remuneration for the conduct of Practicals and Theory valuation of the said course in tune with the remuneration for B.Sc / M.Sc Para Medical course, vide paper read as 1<sup>st</sup> above. The rates for B.Sc/M.Sc Para Medical courses has been fixed vide U.O. No. 31/2017/PB dated 12/01/2017.

The proposal and the matter of settlement of the bills already submitted, if any, in tune with the pre-revised rates of B.Sc/ M.Sc Para-Medical course, was placed before the Standing Committee of the Syndicate on Examinations held on 11/01/2018, and as per paper read as 2<sup>nd</sup> above, the SC on Examinations vide item No. 1 resolved to place the same before the Syndicate with recommendation.

Vide paper read as 3<sup>rd</sup> above, the Syndicate considered the question of fixing the rate of remuneration for B.Voc MLT course in tune with B.Sc / M.Sc Para Medical course which is fixed as per U.O. No. 31/2017/PB dated 12/01/2017 as requested by the Chairman and also the settlement of the bills already submitted, if any, in tune with the pre-revised rates of B.Sc/ M.Sc Para-Medical course, and deferred for detailed study by a committee consisting of Prof. R. Bindu (Convenor), Sri. K.K. Haneefa and Dr. T.M. Vijayan.

The Committee which met on 13.04.2018, as per paper read as 4<sup>th</sup> above, recommended to fix the rate of remuneration for B.Voc in MLT in tune with remuneration of B.Sc / M.Sc Para Medical

course which is fixed as per U.O. No. 31/2017/PB dated 12/01/2017 and to settle the bills already submitted, if any , in tune with U.O. No. ECQ/2/Fix of Remn/10-11 dated 02/08/2010.
