ORDER

As per paper read as 1st above, the EAC Section, Finance Branch informed that the rate of remuneration for the valuation of answer scripts of Certificate Course in Laptop and Desktop Engineering was not fixed so far and hence the bills regarding the theory and practical exams were kept pending.

The Chairperson, Board of Examiners was requested to forward a proposal on the same and accordingly, the following proposal was forwarded as per paper read as 2nd above.

Theory - ₹10/- per paper.

Practical - ₹12/- per student.

The Standing Committee of the Syndicate on Examinations, vide paper read as 3rd above, resolved to place the same before the Syndicate with recommendation.

The Syndicate, as per paper read as 4th above, deferred the same for detailed study by Standing Committee on Examinations.

In the mean time, the Finance Branch, as per paper read as 5th above, forwarded the list of following UG Diploma and Certificate courses for which no remuneration has been fixed so far.
