ORDER

As per the paper read (1) above, the Syndicate held on 30.01.2019, resolved to explore the possibility of taking advance by the Controller of Examinations and distribute to the Principal of the affiliated colleges for conducting examinastions. The advance to the Principals shall be given by the Controller of examinations, taking into account the amount spent in the last year for the conduct of examinations. The decision was implemented vide order read (2) above.

Accordingly a sub committee meeting was held on 06-02-2019, chaired by the Vice Chancellor, involving Pro-Vice Chancellor, Prof.R.Bindu, Member Syndicate, Dr.C.L.Joshy, Member Syndicate, Sri.K.K Haneefa, Member Syndicate, Controller of Examinations and Finance Officer. The meeting resolved the following in connection with speedy disposal of bills pertaining to Conduct of Examinations.

- 1. The Principals of affiliated colleges have to submit the bills of conduct of examinations for the period from 1st September to 28th February (i.e I session) on or before 31st March and bills for the period from 1st March to August 31st (i.e II session) on or before 30th September of the year.
- 2. The payment of 1st and II sessions shall be made on or before 30th June and 30th December of the year, respectively.
- 3. Pareeksha Bhaven and Finance Branch shall make necessary arrangements for the implementation of the above and prepare a time schedule for it.
 - 4. The new System shall commence from 01.03.2019 onwards.
- 5. In the case of bills already collected by EAC sections, payment will be effected by conducting 'adalaths' after 30.06.2019.
- 6. Sanction has, therefore, been accorded by the Hon'ble Vice Chancellor subject to ratification by the Syndicate, to implement the above minutes of the meeting of the sub committee held on 06-02-2019.

Orders are issued accordingly.
