Sub : Election to the Academic Council of the University of Calicut as per sub section (3) (l), (m), (p) and (r) of Section 24 of the Calicut University Act 1975

### NOTIFICATION

Whereas it is necessary to reconstitute the Academic Council of the University in accordance with the provisions of the Calicut University Act 1975, it is hereby notified that the elections will be held according to the principle of proportional representation by means of single transferable vote and in accordance with the procedure laid down in the Calicut University First Statutes, 1975 on Elections to elect.

(1) Five members (other than Deans of Faculties) of whom at least one shall be the Principal of a Government Professional college, elected by the Principals of Professional Colleges from among themselves as per Section 24(3)(l).

(2) Seven members (other than Deans of Faculties) of whom at least one shall be the Principal of a Government College elected by the Principals of first grade colleges other than colleges of oriental languages from among themselves as per Section 24(3)(m) .

(3) One member each of every subject of study (not being a Dean of faculty or head of a University Department or Principal) elected by the teachers of that subject from among themselves as per Section 24(3)(p) and

(4) One member representing each faculty elected by the full time post graduate students of the faculty from among themselves as per Section 24(3)(r).

Elections as noted in (1) and (2) above will be held by postal ballot and (3) and (4) will be held without postal ballot in accordance with provisions of Part B of Chapter 3, providing polling Stations in every college and University Departments. The teachers and students of the Colleges/University Departments whose names are in the electoral roll concerned shall be entitled to vote only at the polling station in their Colleges/University Departments.
