**ORDER**

As per per read as (1) above, Smt.Thanzeela Ebrahim. K requested for granting equivalency to MBA (Financial Management) of Bharathiar University under distance mode with MBA of the University of Calicut.

Vide paper read as (2) above, the Board of Studies in Management Studies (PG) considered the request of Ms.Thanzeela Ebrahim K for granting equivalency to MBA (Financial Management) of Bharathiar University under distance mode with MBA of the University of Calicut. The Board observed that as per the Regulation & Syllabi, the minimum eligibility for admission to MBA Programme of Bharathiar University under SDE mode is a pass in Degree Examination, whereas in University of Calicut, it is a pass with not less than 50% mark. Hence, in general, the MBA degree awarded by Bharathiar University (distance mode) cannot be equated to MBA degree of University of Calicut. However since this particular candidate passed the degree with overall B+ grade from University of Calicut and completed the MBA from Bharathiar University, the Board recommended to equate the MBA Degree (Finanacial Management) awarded by Bharathiar University (Distance mode) to Ms.Thanzeela Ebrahim K as equivalent to MBA degree of Calicut University as a special case.

Vide paper read as (3) above, the meeting of the Faculty of Commerce and Management Studies approved the remarks of the Board of Studies in Management Studies (PG).

Vide paper read as (4) above, the Academic Council resolved to grant equivalency to MBA Degree (Financial Management) under distance mode awarded by Bharathiar University to Ms.Thanzeela Ebrahim K with MBA of the University of Calicut, as recommended by the Board of Studies in Management Studies (PG) and approved by the Faculty as a special case.
