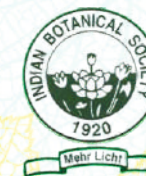

It is a matter of great pleasure to invite all IBS members to participate in the scientific sessions, symposia, poster presentations and other activities of the conference for exchange of thoughts, opinions and scientific interactions.

UNIVERSITY OF CALICUT

Established in 1968, the University of Calicut is the largest institution of higher learning in Kerala. With 38 post-graduate departments and 392 affiliated colleges, the University aims to nurture excellence in education and research in Kerala. The University of Calicut is accredited by NAAC with 'A' Grade and ranked 73 among Indian Universities by the National Institutional Ranking Framework (NIRF) in 2018. According to QS India University Ranking of 2019, University of Calicut stands in 39th position. The beautiful and well-planned campus spreads over 500 acres is situated at Kozhikode-Thrissur road towards the south at a distance of 23 km from Kozhikode city and is well connected by Air (8 km to Calicut International Airport, CCJ) and Rail (14 km to the nearest railway station, Parappanangadi).

DEPARTMENT OF BOTANY

The Department is offering programmes such as M.Sc. (Applied Plant Science), M.Phil. (Botany) and Ph.D. (Botany & Environmental Science) and is supported by DST-FIST (2 cycles) and KSCSTE-SARD programmes. The Department has an internationally recognized Herbarium (CALI) and an excellent Botanical Garden (CUBG) with diverse collections of ginger, ferns, medicinal and aromatic plants. THE ALL INDIA BOTANICAL CONFERENCE AND NATIONAL SYMPOSIUM ON “INNOVATIONS AND INVENTIONS IN PLANT SCIENCE RESEARCH”

The three-day conference, besides the presidential address and felicitation of a distinguished botanist for exceptional life time services to Plant Sciences, will have four medal award lectures, two memorial award lectures, two award contest sessions. There shall be eight concurrent sessions for presentation of original research papers and posters in different sections* given below:

1. Mycology, Microbiology, Plant Pathology including Seed Pathology.
2. Cryptogamic Botany (including Fossil Cryptogams).
3. Seed Plants (including Fossils), Anatomy, Reproductive Biology, Embryology including Study of Seed and Fruit.
4. Taxonomy of Seed Plants, Floristics including Biodiversity, Economic Botany Ethnobotany and Pharmacognosy.
5. Cell and Molecular Biology, Cytogenetics and Plant Breeding.
6. Ecology, Phytogeography and Environmental Botany.
7. Plant Physiology, Biochemistry and Pharmacology.
8. Morphogenesis, Plant Tissue Culture and Biotechnology.

H.Y. Mohan Ram Award for Excellence in Teaching and Advancement of Plant Sciences

P.C. Trivedi Medal Award for Editorial Excellence

ABSTRACT

Members intending to participate should send a soft copy of the full manuscript along with the copies of illustrations and an abstract (limited to 200 words), on a separate sheet mentioning the scientific section* prepared in MS word in "Times New Roman" font 12pt and 1.5 spacing, should also be sent by e-mail to The Organizing Secretary, 42nd AIBC, Prof. Santhosh Nampy at: calicutibs2019@gmail.com with a copy to Prof. Seshu Lavania, Secretary IBS, Department of Botany, University of Lucknow, Lucknow – 226 007 (UP) on or before 30th September, 2019 through e-mail at: secretaryibs2017@gmail.com. Abstract can also submit through online.

No member is allowed to submit more than two abstracts, including as co-author. The papers received after 30th September, 2019, and the abstracts not accompanied by full papers, or sent by non-members or by those who have not paid membership dues for 2019 will not be considered. All authors of a paper must be the member of the Society. The abstract, if accepted after scrutiny, will be published in the book of abstracts of the All India Botanical Conference.

CERTIFICATE OF MERIT / MEDAL IN DIFFERENT SECTIONS

In order to encourage young scientists below the age of 30 years** as on 31st December, 2019, the society awards 'Certificate of Merit' and medals instituted in honour of Senior Botanists (Prof. Jafar Nizam, Prof. Y.D. Tyagi, Prof. L.P. Mall, Prof. O.P. Mall, Prof. C.P. Malik, Prof. S.N. Chaturvedi, Prof. Y.S. Murty and Prof. H.C. Arya) for the Best Paper presented (if recommended by experts) in each section. The first or the presenter author should not be above 30 years.

At least three papers should be presented for the award of medal in each section. Date of birth of each author/co-author must be given below his/her name, failing which the paper/poster shall not be considered for the contest (name of supervisor may be included as the co-author irrespective of age, but only the presenting author within the age group shall be considered for the certificate / medal). No member shall be eligible to receive the certificate and/ medal for a second time in the same section or in another section in the same category. The same applies to the awards of the Society.

**A certified copy of the High School Certificate / proof of age must be enclosed with the paper by the prospective young contestants under the Oral Presentation category.]

AWARDS FOR LIFE MEMBERS OF THE SOCIETY

Young Botanist Award Contest: A separate section will be held for young Botanists below the age of 35 years as on 31st December, 2019, for presenting their paper in the section of the Young Botanist Award. Applicants should submit full paper in triplicate for this contest by 31st August 2019 along-with other required information as per the given proforma, to The Secretary, Indian Botanical Society. Applications submitted under this category shall be scrutinized by an expert committee, and only three best selected papers shall be allowed for presentation during the conference for final selection. Each participant will be given 18 minutes for paper presentation followed by 5 minutes for discussion. The best presentation shall get Young Botanist Award 2019 (Dr. Bahadur Singh Gold Medal), of the Indian Botanical Society.

Prof. Y.S. Murty Memorial Gold Medal: A medal will be awarded to an outstanding plant morphologist/taxonomist up to the age of 50 years for his/her research contributions in any group of plant kingdom. Contestants are required to send their detailed applications as per given proforma providing list of publications and reprints of 10 best publications for evaluation by the expert committee constituted for the purpose. The last date of receipt of applications for this award in the office of the Secretary, Indian Botanical Society is 31st August, 2019.

Prof. S.V.S. Chauhan Gold Medal: A medal will be awarded to one of the youngest participants (from all the sections) up to the age of 25 years as on 31st December, 2019 who has presented his/her research paper in any group of plant kingdom. Life members can submit their paper (single authorship) for this contest by 31st August, 2019.

MEDAL/AWARD FOR WOMEN SCIENTISTS

Woman Scientist Medal: A medal for Women Scientist up to the age of 50 years is instituted by the society to recognize lady botanists. Applications are invited as per the given proforma (available at www.indianbotsoc.org) providing list of publications and reprints of 10 best papers published for evaluation by the expert committee constituted for the purpose. The last date of the receipt of the nominations is 31st August, 2019 to the Secretary, Indian Botanical Society.

Woman Botanist Award: A separate section will be held for Woman Botanists below the age of 50 years for presenting their paper in the section of the Woman Botanist Award. Applicants should submit full paper in triplicate for this contest by 31st August 2019 along-with other required information as per the given proforma, to the Secretary, Indian Botanical Society. Applications submitted under this category shall be scrutinized by an expert committee, and only three best selected papers shall be allowed for presentation during the conference for final selection. Each participant will be given 18 minutes for paper presentation followed by 5 minutes for discussion. The best presentation shall get the Woman Botanist Award 2019 of the Indian Botanical Society.

Prof. S.C. Dixit cash prize: This award carries cash prize of Rs. 1000/-, and is awarded for the best article published by a woman candidate (single author) in the Journal of Indian Botanical Society for the year i.e. published in 2018 (vol. 97).

POSTER AWARD CONTEST

- (i) Prof. K.S. Bilgrami Gold Medal (author below the age of 35 years) and
- (ii) Prof. S.N. Dixit Gold Medal (author below the age of 50 years).

The restriction of age limit shall not apply to the Ph.D supervisor if happens to be a coauthor, but cannot be a participating contestant.
