## **ORDER**

Vide paper read as (1) above, equivalency certificates (for both higher studies and employment) were issued for all regular degrees of Universities or Deemed to be Universities (IITs, IISc, NIT, IISER, NISER, NIST etc.) enacted by an act of the State Legislative Assembly or Parliament with the corresponding degree of this University provided that those courses/programmes were of the same duration of the courses/programmes of this University, having the same nomenclature in the same discipline and same eligibility criteria.

The new policy on Equivalency/Recognition of courses which was implemented vide paper read as (2) above, insisted 60% content similarity between the syllabi, in addition to other conditions prescribed. This was made effective only in the case of degrees successfully completed on or after the implemention of the new policy.

As per paper read as (3) above, the new regulations on Recognition and Equivalency of Programmes of study 2017 were implemented which superseded all regulations on Recognition and Equivalency which were in force till then.

Vide paper read as (4) above, the Sub Committee on Recognition and Equivalency of programmes of study held on 31.10.2017, considered the grievances faced by the students after implementing the new regulations of recognition and equivalency vide U O No. 9998/2017/Admn dated 09.08.2017 and recommended to extend the benefit of granting equivalency to all regular degree programmes of central and state universities or deemed to be universities and reputed institutes of national importance like IITs, , NITs, IISER, NISER NIST etc till 2014 admission for UG programmes, 2015 admission for PG Programmes and till 2016 admission for M Phil Programmes subject to the following conditions.

- (a) The duration of the programme of the other institution is the same or longer
- (b) The eligibility criteria of the programme of the other academic institution are the same or higher
- (c) If the minimum requirements for a pass in the programme of study of the other institution are less, yet, if the candidate meets the minimum requirements individually as per this University's programme requirements, the equivalency can be granted.
- (d) The UG programme should be completed in 10+2+3 pattern and PG Programme in 10+2+3+2 (or 10+2+5 for integrated programme) or longer duration.
- (e)The nomenclature of the programme shall be the same as that of the programme offered under this University.

The recommendation of the meeting of the Sub Committee on Recognition and Equivalency of programmes of study held on 31.10.2017 has been approved by the Vice Chancellor subject to ratification by the Academic Council, vide orders read as (5) above.

Sanction is therefore accorded for extending the benefit of granting equivalency to all regular degree programmes of central and state universities or deemed to be universities and reputed institutes of national importance like IITs, IISc, NITs, IISER, NISER, NIST etc ti II 2014 admission for UG programmes, 2015 admission for PG Programmes and till 2016 admission for M Phil Programmes, on fulfilment of the above conditions, subject to ratification by the Academic Council .
