According to paper read as (1), the Board of Studies in Architecture in its meeting held on 11.11.2016 resolved that request for internal revisions of marks in theory can be extended to B.Arch students after it has been put into practice for B.Tech.

According to paper read as (2), the Academic Council approved the Minutes of the meeting of the Board of studies in Architecture held on 11.11.2016.

As per U.O's read as (3) and (4), orders were issued on the improvement of internal marks for B.Tech students.

As per paper read as (5), clarifications were sought from the Chairperson, Board of Studies in Architecture on framing the guidelines for improvement of internal marks for B.Arch students. The Chairperson suggested vide paper read as (6) that the same guidelines for B.Tech can be followed for improvement of internal marks of B.Arch and clarified that unlike B.Tech there is only one regulation of 2004 for B.Arch.

As per paper read as (7), the Syndicate resolved to prescribe the fee as in the case of B.Tech programme for intenal improvement of B.Arch also.

The Vice Chancellor, after considering the resolution of the Academic Council vide paper read as (2) and the resolution of the Syndicate vide paper read (7) has accorded sanction to issue the following orders;

1.B.Arch students of 2004 regulations, who have completed B.Arch course work will be given chance to improve their internal marks in the failed subjects, in the Colleges they studied.

2.In case the College or course they studied does not exist now, they can register in a College willing to take up them.

3. In all such cases, the maximum internal marks after improvement should be limited to 70%.

4. The internal continuous assessment should be done as per the scheme and regulations the student studied earlier.

5.Such improvement of internal marks will not be permitted for students who have passed the B.Arch programme.

6. The fee for such improvement of internal marks will be as follows;

a) Rs.1000/- per course(or paper)as examination charges, which is to be collected by the College.

b) Rs.500/- per course (or paper) as registration fee, which is to be paid to the University fund.
