**ORDER**

Many colleges failed to collect and remit the HWD Fee dues (concession given to SC/ST/OEC students) in time to the University Fund leading to serious objections by the audit authorities. The Monitoring Committee of the Internal Audit Wing decided to initiate strict action towards collection of fee dues from HWD and directed Pareeksha Bhavan to resolve the issue at the earliest.

At first, the mark lists and certificates of PG Students from Govt.Colleges availing fee concession were withheld. As the Govt.colleges receive the amount from Harijan Welfare Department very late, it was later suggested that the results of candidates under educational concession may be released on the basis of a declaration obtained from the Principals concerned. The Hon'ble Vice-Chancellor after considering the matter and also considering the Syndicate decision not to penalize the students for the fault of college authorities, ordered to release the mark lists/grade cards of the candidates under educational concession on the basis of a declaration obtained from the Principals to the effect that they will remit the fee dues to the CUF immediately on receipt from the Harijan Welfare Department without fail. The Hon'ble Vice Chancellor also ordered to direct the Directorate of Admissions (DoA) to withhold/suspend the admission and College Development Council (CDC) to withhold all services rendered by University to such colleges which are having fee dues until the dues are cleared in full. The same was implemented as per U.O. read as 1<sup>st</sup> and 2<sup>nd</sup> above.

Accordingly the list of colleges having HWD fee dues were forwarded from Pareeksha Bhavan to CDC / DoA. The Director, CDC as per the directions in the U.O's read above, withheld all services to those colleges. It was informed that those colleges included in the list shall be eligible for all services from CDC only on the production of a Non Liability Certificate to the effect that the dues are cleared in full.

The Members of the Syndicate vide reference cited 3<sup>rd</sup> above, informed that the Syndicate has decided to give confirmation of affiliation to PG Programmes in order to sanction Research Centres and the same is not given to some of the Programmes in Arts & Science Colleges even after successful completion of the inspection and hence requested to take necessary steps to solve the crisis.

The whole matter was placed before the Standing Committee of the Syndicate on Examinations held on 25/04/2017. It was submitted that the Pareeksha Bhavan has no other means to ensure the remittance of dues avoiding loss to the University and also informed that any change in this system may badly affect the clearance of dues. The Standing Committee on Examinations as per reference cited 4<sup>th</sup> above, vide item No. 4, resolved to place the matter before the Syndicate with the list of defaulting colleges and amount due.

The Syndicate as per paper read as 5<sup>th</sup> above, considered the request received from the members of the Syndicate to reconsider the decision regarding withholding the services rendered by CDC to affiliated colleges and resolved to stick on the existing decision to withhold the services.

Sanction has therefore been accorded by the Hon'ble Vice-Chancellor to implement the decision of the Syndicate.

Orders are issued accordingly.
