5. The rate quoted should include taxes and all other charges including installation and delivery charges. The base rate, GST and other charges if any should be shown separately in the tender.
6. The **GST registration** is mandatory for participants in the tender. The GST Number and a copy of the GST registration certificate shall be enclosed with the tender.
7. The successful bidder must furnish a **performance security deposit @ 5%** of the total value of the contract and execute an **agreement** at his own cost in Stamp Paper worth Rs.200/- for the satisfactory fulfillment of the contract where the contract value is above Rs. 1,00,000/-. The EMD and performance security are refundable.
8. All Store Purchase rules of Kerala Government will be applicable to the tender.
