All bid/tender documents are to be submitted online and in the designated cover(s)/envelope(s) on the e-GP website. Tenders/bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted.

The scanned copies of registration certificate shall be duly attested by a Gazetted Officer, Declaration in the form uploaded, Preliminary Agreement, EMD exemption certificate (if any) and BOQ shall be submitted online and subsequently in a separate cover. More details on EMD & Cost of Tender documents/bid submission fee are mentioned in the Form 83 document.

The bids shall be opened online at the office of the Executive Engineer (Electrical), Engineering Department on **18.01.2018** at **5.00 P.M** by the Executive Engineer (Electrical) in the presence of the Bidders/their representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place.

Online Tenders / bids are to be accompanied with a scanned copy of the preliminary agreement executed in Kerala stamp paper worth **Rs. 200/-**. Tenders / bids received online without the scanned copy of preliminary agreement, attested valid Registration certificate, Declaration in the form uploaded duly filled and signed and BOQ will not be considered. Further details can be had from the Office of the Executive Engineer (Electrical) during working hours.


The hard copies of original preliminary agreement properly signed, attested copies of registration certificate, EMD exemption certificate (if any), Declaration in the form uploaded, Tender Documents duly filled signed and sealed in all relevant pages to be submitted before the time fixed for tender opening.

All other existing conditions related to tender of Kerala PWD will be applicable in this tender also. The Engineering Department, University of Calicut will not be responsible for any error like missing of schedule data while downloading / uploading by the Bidder. The tender inviting authority reserves the right to accept or reject any tender without assigning any reason thereof.

***All network nodes shall be tested with latest state/mode of the art, FLUKE DTX cable analyzer and the report shall be submitted to the Electrical Wing on completion of the work. Valid calibration certificate from Government Agency for the Flute Testing Equipment shall also be submitted.***

The Project shall be completed within the Agreement Period and the contractor shall submit a completion report to the undersigned on the next working day after the completion of the Project or otherwise Penalty as per rules will be deducted from the final bill for belated completion of the Project as per the Revised Kerala PWD Manual.
