Qualification:- The qualification for the said posts will be as per the UGC norms for Assistant Professors (PG with 55% aggregate in the relevant subject + NET).

Age limit as on 01.01.2017 : Below 40 years (Upper age limit prescribed will be relaxed in the case of OBC, SC/ST and Physically Challenged persons by 3 years, 5 years and 10 years respectively subject to the relevant provisions of KS&SSR.)

Remuneration: The remuneration for the post of Assistant Professors on contract will be Rs. 25,000/- (Rupees twenty five thousand only) per month (consolidated).

Nature of appointment:- Contract

Term of Contract : One year from the date of joining.

Duties and Responsibilities:

- 1) Function as the Programme Coordinator for the respective Programmes in general.
- 2) Supervision of all the academic activities related to the conduct of the concerned Programme of School of Distance Education.
- 3) Engaging contact classes.
- 4) Co -ordinating contact classes and distribution of study materials.
- 5) Preparation of study materials.

6) Organizing seminars and workshops.

7) Any other academic or administrative duties assigned by the Director, SDE/University authorities

General conditions:

- Candidates who have passed their qualifying examination from Universities outside Kerala should produce equivalency certificate obtained from this University at the time of interview.
- Reservation benefit shall be applicable to only those communities which are mentioned in the KS & SSR.
- The engagement on contract basis shall be for a period of one year from the date of joining.
- Candidates should produce Original Certificates to prove age, qualification and Community (Non-creamy-layer certificate to those belonging to OBC) at the time of interview.
