Instructions to the candidates who have been provisionally listed for the interview to the post of Assistant Professor (on contract) in Hindi for Calicut University Centre at Kadmat as per the notification no: 12988/LD- ASST-2/2013/CU dated 04.01.2019

1. Only those candidates who are qualified as per the notification will be eligible to attend the interview.

2. Self-attested print-out of the online application should be produced at the time of verification.

3. The testimonials in original, such as proof of age, qualifications including Research Experience and Seminar Presentation, Publications, Teaching Experience, community/caste, nativity in the case of Lakshadweep candidates and other claims made in the application form, should be produced.

4. In cases where only the CGPA is given (percentage is specifically not given) in the Consolidated Mark List, the candidates should produce the percentage certificate issued by the Competent authority indicating the exact percentage of marks attained in the Qualifying Examination.

5. It is compulsory to produce Equivalency Certificate in the case of those who have passed their PG from other Universities in Kerala and outside. In such cases, candidates should obtain the Equivalency Certificate in advance from the Equivalency Section, situated at the Tagore Niketan in the university main campus (Ph: 0494 2407330). Such candidates will not be considered without Equivalency Certificate.

6. Those who are eligible to be considered under reservation category should produce Caste/Community certificate (in the case of SC/ST) and Non-Creamy Layer Certificate (in the case of OBC) at the time of verification.

7. Non NET candidates will be considered only in the absence of NET holders.

8. No TA & DA will be paid for the journey.

9. The inclusion of the names in the list below is purely provisional. The list is prepared on the basis of online applications submitted by the candidates.
